CHAPTER - I INTRODUCTION

1.1 Background

Initiated by academicians, intellectuals and social workers residing in Kuleshwar Area, Janamaitri Multiple Campus (JMC) was established in 1991 AD (2047 BS). Located at Kuleshwar residential area, the campus is easily accessible due to its prime location. It has come to be known as a pioneering academic institution.

As a non-profit community campus, the campus is dedicated to serve the people, society and the nation by imparting quality education. Conducive academic environment, mutual understanding, high regards to social values and practice-based education are some of the notable features of the campus. The campus has been able to ensure quality education even with low initial investment due to dedication and commitment of students, faculty members and entire management. Since its establishment, JMC has contributed to enhance access of education to all by offering scholarship to socially marginalized and economically disadvantaged, differently able and meritorious students by offering scholarship for ensuring inclusiveness in education.

The campus has given high priority to the optimal utilization of the available resources, in order to expand and upgrade the available resources for promoting academic excellence. The campus has succeeded to acquire around 2200sq.m. land and constructed four floor of proposed five storey building which has been possible due to the contribution of management committee, teacher and Staff. The entire mission of the campus is guided by the vision for developing JMC as a deemed university in foreseeable future.

The enrolment status, academic results and the overall performance of this campus gave ground to the University Grant Commission for selecting it in the B Grade for financial support under Second Higher Education Project (SHEP). Both performance grants and matching grants from UGC made invaluable contribution to uplift the institution to a great extent. Continuing the same spirit, the campus has been selected by the UGC under Higher Secondary Reform Project (HERP) in 2016 AD.

The campus has been awarded Quality Assurance and Accreditation certificate by the University Grant Commission in 2019.

CHAPTER - II

ACADEMIC PROGRESS

This chapter covers a brief description of academic programs, student's enrolment status, human capital formation, provision of services through certain departments and units and some recent developments.

JMC began its services since 1991 AD in affiliation to Tribhuvan University with intermediate level in law and humanities. Similarly, the academic program of HSEB in Management, Education and Humanities was started in 1997 AD. With the growing demand, the campus started bachelor level program in Management in 2003 AD. In 2004 Humanities and Education bachelor program were introduced. Furthermore, master level programs in Management (MBS) and Education (M.Ed) were started in 2010 AD. Likewise, the BICT program was introduced in 2015 A.D. BCA and BBM program were introduced in 2019 A.D.

With the beginning of the second lockdown to control the Covid-19 outbreak, many educational institutions have started switching from traditional classroom teaching

toonline teaching to cope with the adverse situation. Tribhuvan University (TU) has also officially endorsed the virtual class model along with a guideline and circulated a notice among its institutions. Similarly, Janamaitri Multiple Campus appealed to teacher and student to start virtual classes through alternative systems.(Annex.2)

Taking into consideration about all of the aspects as mentioned above, Janamaitri Multiple Campus has also been applying ICT based pedagogies, teaching materials and methods for effective academic outputs of the learners to make them competitive in global markets and RSQ process also applied in teaching learning activities to make teaching and learning more effective and practical, to bring positive behavioral changes in students and to gain educational objective *Benjamin Bloom's* concept of Taxonomy of Educational Objective has been adopted.

The campus has adopted all mechanisms for making students to be active learners with dynamic teaching methods and technologies. Therefore, the campus has applied modern technologies, modern teaching materials, and student-centered teaching methods. To fulfill this purpose, there is management of overhead projector (OHP) and PowerPoint Multimedia in the field of teaching to make students' learning process easy Janamaitri Multiple Campus has planned to make adjustment of modern ICT based technology in all classrooms gradually in the future. Similarly, there is also provision to connect projector– based presentation for instant requirement.

Though lecture method was in maximum use in teaching learning process in traditional system, the updated training and orientation programs are timely being provided to all lecturers so that more student - oriented methods are in use in JMC; which is gradually being improved.

To make improvement in more student-centered teaching learning process, students will be provided changing experiences in learning process through field trips and educational tours so that students will have chances to conduct research and field study in a practical way. Moreover, the campus has played positive and supportive roles for this aspect. The chances to students are provided to participate in extracurricular and co-curricular activities with formation of different groups among themselves. In addition, to enhance the skill and capacity of students in journalism, there is a provision of a radio lab with Janamaitri Siksha Chautari program which has made broadcasting system via different F.Ms. To develop students' learning capacity, the campus has regularly conducted Home Assignment, Unit Test and Regular Attendance systems thinking them as been of prime importance in order to make effective Terminal Test. To make students' learning process more effective through judgment, **Terminal Tests** are conducted three times in a session. There is also provision of reward for the inspiration of the students. Every period will be of 45 to 50 minutes. As a whole, the teaching and learning activities have been conducted with modernized effective teaching methods and materials in Janamaitri Campus. So there is transformation of higher education in Janamaitri Multiple Campus to make more effective and innovative learning process. This situation has made Janamaitri Campus different from traditional teaching system. In reality, students find more facilitating and supportive environment in Janamaitri Campus. Janamaitri Multiple Campus is a well-known community campus that provides services to students from various socioeconomic backgrounds under the motto "Quality Education at Affordable Fees." However, the systematic efforts of the graduates' professional settlement began on campus after it received QAA certification from the University Grants Commission. The Counseling and Placement Unit, which has been created in accordance with the requirements of

the QAA spirit, has been tasked with preparing students for a smooth transition into their professional lives.

The provision has been designed to prepare esteemed students for the professional life by providing counseling, training, and internships. Lockdowns at various times have hampered the effective implementation of the unit's action plan. The following are some of the achievements made by the unit during the academic year 2021:

- a. - b. An orientation program was conducted 07/04/2021 on the topic: Fostering 21st Century Skills for Global Competitiveness in support of Dr. Ramhari Lamichhane, Director General of CPSC (Colombo Plan Staff College), Manila, Philippines to the internal management members including senior faculties. The program was highly beneficial and it assisted the participants to counsel the students for their preparation in globally competitive professional market especially to teach mind, train hand and touch heart.
- c. A Memorandum of Understanding (MOU) was signed on 24/08/2021 between Janamaitri Multiple Campus and Loop Networks Limited An ISO 9001: 2015 certified company for "exchange of services" for the internship services and job placement of the campus graduates. The campus has already sent five students of Management for their short term training in marketing skills.
- d. An understanding was made with Mr. Khim Lal Pandey, Chairman of Sakushal Bachat Tatha Rin Sahakari Ltd. Kuleshwar on 06/09/2021 regarding the recruitment of the students in his organization. He appointed two of our students, Miss Shanti Rijal and Miss Sita Rijal, in his organizations. We have made understanding for the continuation of reciprocal relationship between two organizations.
- e. A discussion program was conducted with the pass out students of Mass Communication and Journalism on 01/10/2021 regarding the easy placement of college graduates in the field. Since they have firmly settled in their professional fields, they shared their invaluable ideas on how the college can foster the probability of easy settlement of the students. They further suggested the campus to continue such ideas sharing programs on regular basis.
- f. The unit made formal contact with Mr. Bhim Kumar Shrestha, the Chairman of Hardik Business Support Pvt. Ltd. Jhamsikhel, Lalitpur on 10/09/2021, Mr. Umesh Adhikari, Proprietor of Study Plus (Focus to Malesia) on 21/08/2021 and Mr. Man Bahadur Shahi, the Chairman of TAG, Kalanki on 27/12/2021 regarding the support in internship and job placement works. They have promised to contract MOU in near future for it.
- g. All the responsible members of Quality Circle, as the class representatives, were given orientation program on 31/12/2021 regarding skill generation for easy professional

settlement during and after their studies. They were offered their badges on the same occasion with the expectation of their distinctive support in overall aspects of campus.

- h. The campus continued the online basic counseling/ training on civic education and human rights to the students of bachelor and plus two level jointly organized with AYON (Association for Youths Organization Nepal) this year as well. The program reminded the need of regular counseling to the students regarding civic rights and responsibilities of the esteemed students for the sake of producing highly cultured and responsible citizens to the nation.
- i. The members of the unit had divided their role and taken initiation of preparing basic and professional non-credit courses such as Basic Computer Training, English Language Training, Account Package, Anchoring etc. The courses have almost been finalized and they will be implemented in near future.
- j. The unit has prepared its annual operation calendar including the proposed activities along with the work division among the members for the accomplishment of the proposed tasks.
- k. All the faculties and the staff of the campus along with the management have been urged formally for their distinct support in recruiting the students currently in the studies and passed from the campus.

Janamaitri ECA Sports Meet

Janamaitri Multiple Campus, Department of ECA organized Extra Curricular Activities as its usual function on the occasion of 31st annual meet in the college. There was a weekly sports meet on different 16 sports genre with the active participation of around 500 students' .All the programmers of diverse genres were organized under the supervision of each coordinator with the equal hold up of the staffs and campus officials.

CHAPTER III PHYSICAL PROGRESS

3.1 Infrastructural Development

Janamaitri Multiple Campus was established in 2047 BS with limited infrastructure and number of students. Initially, it had launched academic program like I.com, I.A. Gradually; the campus has been expanding its program and its overall structures. It has faced so many ups and downs to reach up to the present state of JMC.

From the very initial stage of its establishment Janamaitri Multiple Campus had collaboration with Kuleshwar Aawas School for construction campus building in Aawas' land having 51 rooms for academic and overall administrative works. After the destructive earthquake occurred on 12th Baishak 2072 BS, the campus faced a complete destruction of its overall infrastructure. On that critical situation of demolishment all campus family had strong determination to continue its pace to go up. For this, management committee, teaching faculties, non-teaching members, students and guardians over all staff played a vital role with creative and constructive supports from their respective grounds. So it compelled to reestablish itself by conducting its academic activities in the building built under the support of University Grand Commission (UGC) with nine rooms at the contemporary critical situation.

At present Janamaitri Multiple Campus has three buildings, overall the campus has 60 class rooms for all academic and non-academic purposes. Specifically, there is a radio lab, computer lab in four rooms consisting 119 computer sets and hardware equipment and three store rooms. Moreover, there is a facilitated spacious library having capacity to 40 people occupied by different administrative offices and department offices. Similarly, the campus has recently constructed a one storey building having perfect classes for class rooms. The building has been constructed with estimated budget 3.7 million. To meet the requirement for academic classes, three stores have been added in the main building donated by UGC, UNCON & Kathmandu District development committee, and other is going on according to campus annual plan. Furthermore, facility related aspects like canteen, pure drinking water, parking, restroom and related facilities are underconstruction. To make campus periphery and environment sanitized and healthy, the process is going on and the four storey building is almost completed. The campus has spread all its efforts to establish a smooth growing, clean and progressive path. To enlarge the main building up to 4storey to meet all its academic and non- academic requirements is campus target and the construction has almost been completed. For this, it has heartily invited all supporting hands, organizations and agencies home and abroad for support.

The campus has succeeded to develop sound infrastructure and learning resources within its own premises. The construction of form and half storey building for classrooms. Labs, library, auditorium and office works. The entire furniture and lab equipment also have been installed and updated. The University Grants Commissions' matching grants were the major sources for the works. Besides, the support of Ministry of Social Development, Bagmati Province, Hetauda, contribution from the senate members and loan from the faculties and staffs also helped in the construction works. As a result, Janamaitri Multiple Campus deserves efficient learning resources and facilities to the students at present.

3.2 Educational Aids

JMC has established a spacious library with open reading space. More than 50 students can read on reading space of library. Daily news papers, weekly and monthly magazines as well as periodicals can be read at library reading room. Reading room has facilitated by LCD projector and speaker. We offer students various motivational documentaries and power point classes on reading room regularly. It has clean drinking water and toilet facilities within premises. The books and other learning resources are issued to the readers on regular basis with the help of E-school software. All the library documents have electronic catalogue. Reference books are various types such as, volumes of encyclopedias, different edition of dictionaries, university level thesis and so on. Nepal related old books, Who's who, biographies of various renowned personas are available to study within library. Back volumes of magazines are collected in reading room and user can enjoy the readings. We collect Kantipur and Gorkhapatra national dailies for a year. Thesis is our new collection for teaching and learning process. We have PhD & MPhil thesis of our faculties, JMC pass out student's thesis of Masters Level and various theses collected from various departments of Tribhuvan University. Introduction

Janamaitri Multiple Campus is a Community College. It is also registered under Inland Revenue Department (IRD) with PAN

A. Significant Accounting Policies:

1. BASIS OF PREPARATION OF FINANCIAL STATEMENTS:

The Financial statements are prepared under the historical cost convention on an Accrual concept and are in accordance with Nepal Accounting Standards and other applicable laws prevalent in Nepal.

2. USE OF ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles requires estimates and assumptions to be made that affect the reported amounts of assets and liabilities and disclosure of contingent liabilities on the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Differences between actual results and estimates are recognized in the periods in which the results are known/materialized.

3. FIXED ASSETS

Fixed Assets are stated at cost inclusive of all expenses incurred in commissioning/putting them into use, less accumulated depreciation.

4. REVENUE RECOGNITION

Revenue from the sale of goods is recognized in the income statement when the significant risk and rewards associated with the inventories have been transferred to the buyer.

5. DEPRECIATION

Depreciation on fixed assets shall be charged on Written Down Value (WDV) Method as per the rates and methods prescribed under income tax Act.

- INVENTORIES (As taken, valued & Certified by the Management) Inventories are stated at the figures, as taken valued & certified by the management. All the trading stocks are valued at Net cost.
- B. Notes on Accounts:
- 1. Previous year's figures have been rearranged and regrouped wherever necessary so as to make them comparable with those of the current year.)
- Organization has not submitted Income Tax Return since previous years, hence no provision for tax has been made.
- 3. Any Differences between actual results and estimates are recognized in the periods in which the results are known/materialized.
- Schedules are the integral part of the financial statements.
- 5. As confirmed by the management, there is no any dispute claimed to/by the firm.
- Not considering any timing differences between taxable income and accounting profit, deferred tax income/expenses are not recognized.
